# Renew your Electricity Social Benefit the easy way

The Electricity Social Benefit is valid for 2 years, except for large families, in which case it remains valid while the family is thus classified.

Renewal must be made at least 15 business days prior to the expiry date of the Electricity Social Benefit. You can consult the expiry date on all your bills.

The renewal process requires the same documents and steps Electricity Social Benefit application process. The following is a summary of the information required to carry out this renewal.








## To renew your Social Benefit, verify that you still meet the requirements:

- **1.** The supply address for which the Electricity Social Benefit needs to be renewed continues to be that of your main residence.
- 2. You continue to meet the personal, family and income requirements for vulnerable consumers:







### Income levels (according to IPREM) to have access to each type of discount:

The IPREM is the Public Indicator of Multiple Income that is updated yearly . It currently amounts to € 7,520 per year.

If the beneficiary has a family member in any of the following circumstances, a higher income threshold will apply, according to the green shaded cell in the table above:

- Recognised disability ≥ 33%.
- Gender violence victim.
- Terrorist victim.

- Degree of dependency, Grade II or III.
- Single-parent family.

<sup>\*</sup> All family members who get the minimum pension in force from Social Security due to retirement or a permanent disability.

<sup>\*\*</sup>A family unit that includes spouses not legally separated or either the father or mother, and in both cases young children who are not yet independent and older children who are legally disabled, as long as they appear in the family record book and in the Residence Registration Certificate.

#### Updating of the application date of the Electricity Social Benefit for large families.

Beneficiaries of the Electricity Social Benefit for being a large family whose certificate is about to expire, who do not wish to verify the income requirement to reach the 40% discount, and who have not had any changes in their family unit since they were granted the social benefit, may opt for an update of the date of application of the Electricity Social Benefit.

In this case, once they have renewed their large family certificate, it will only be necessary to provide the following documentation:

- Specific form updating the date of application of the Electricity Social Benefit, which can be requested at Customer Service Points or by calling (900 200 708).
- Photocopy of the renewed large family certificate.

This documentation can be presented at Customer Service Points or sent by email or by post.
